Factors that define the term "Farmers Market" and distinguish farmers markets from roadside stands, grocery stores, and from other types of food marketing outlets include groups of farmers selling produce and food products they raise or home process to individual customers at a temporary or permanent location, often on public property, such as a street or parking lot on a periodic basis, typically once or twice a week for a set period, usually 3 or 4 hours. This generally occurs during the local growing season, usually 5 or 6 months and is operated by a government or non-profit organization.
